Supporting Infrastructure: A Price Adjustment Ahead

Who does this affect?

AP&T power customers in Haines & Skagway.

What happened?

AP&T repaired the undersea cable that connects Haines and Skagway. This, along with inflation, has caused the utility to operate in a deficit.

Why was this important?

If this cable section were to fail, Haines and Skagway utility systems would become isolated, impacting energy costs, decreasing reliability, and increasing fossil fuel use.

How does this affect me?

Request TA7-521 will be filed to the Regulatory Commission of Alaska (RCA) for a rate increase. If approved, customer's will see an increase in their monthly bill. Residential customer's should only notice a small change due to the **PCE Credit**.

When will this happen?

The proceedings will begin January 2025 and take approximately 15 months. An interim rate has been requested during the rate case. You may see these changes on your next statement.



Sample Bill

Below examples show upcoming rate changes based on 500 KwH of usage for both residential and small commercial users. These rates are sans tax for simplicity.

*the Energy Charge includes only the costs of energy and exclude the COPA balancing account, which will initially have a surplus that further reduces the impact of the rate increase.

What is the PCE Credit?

PCE is the Power Cost Equalization Program. It "provides economic assistance to communities and residents of rural electric utilities where the cost of electricity can be three to five times higher than for customers in more urban areas of the state."**
